President's Report

January Report - Dr. Gregory Busch

- We have signed our contract with Pepsi, we will be a Pepsi school, with sign-on and corporation agreement plus bonuses and we will earn additional resources, score boards, etc., earnings of thousands of dollars.
- BSN Sports and Underarmor will also have a positive impact regarding our revenue.
- > Thank you to Ms. Gillard and the whole team for making significant steps

in getting a plethora of reports to Higher Education Department.

- Thank you, Mr. Morgan, for your presentation at the hearing before the department of Higher Educations Capital Improvements Committee regarding the implementation of our Campus Master Plan, which has been presented to you and approved for the renovation of building "A" to change the entrance to the north side of the building facing 11th street "Campus Drive". The committee approved these plans unanimously, Mr. Gerald Hoehne praised Mesalands for developing a superb master plan designed for student success. Mr. Morgan is in the process of getting contractors lined-up and should begin the project in about a month. There were some questions about moving the bookstore, we don't have a bookstore, I said "we have a Mesalands Stampede Mercantile."
- Next Wednesday, January 26th Mesalands will be visited by Congressman Fernandez from 9:45-12:00 at the Wind Energy Center, she wants to learn what we are doing with Hispanic Serving Institution (HIS), and Renewable Energy. I encourage members of Board to come and greet the Congresswoman.

ACTION - Approval for emergency start/end date for Spring 2022 classes – classes will begin no sooner than 1/31/22, end 5/13/22 and keep intact our Spring Break by extending classes by 15 minutes, and extend classes one week to May 13, 2022.

ACTION – Mr. Sandoval moved to approve the Emergency start/end date for Spring 2022 classes. Mr. Sidwell seconded the motion. A roll call vote was taken with members voting: Mr. Streetman, yes; Mr. Sandoval, yes; Mr. Sidwell, yes; and Ms. Stephenson, yes. The motion carried.

ACTION - Approval of Revised 2021-2022 Academic Calendar

ACTION – Mr. Sandoval moved to approve the revised 2021-2022 Academic Calendar. Ms. Stephenson seconded the motion. A roll call vote was taken with members voting: Mr. Sandoval, yes; Mr. Sidwell, yes, Ms. Stephenson, yes; and Mr. Streetman, yes. The motion carried.

ACTION - Revision to Mesalands Community College Safe and Healthy Campus policy section 18.1 - Covid Vaccination – **ACTION**

The US Supreme court ruled mandates placed on OSHA to remove the mandate. Dr. Busch recommends that the mandate be removed, and revised to say the vaccine is strongly encouraged, but not required or mandatory, so the exemptions are no longer required.

The Omnicom variant is greatly detoured using the N95 mask. We should require the N95 mask.

Mr. Streetman made the statement since the situation on Covid is so fluid and constantly changing, he would recommend the Board give Dr. Busch and his administration the authority to revise the policy as needed.

ACTION – Mr. Sandoval moved to approve the Revision to the Mesalands Community College Safe and Healthy Campus policy section 18.1 Covid Vaccination and give Dr. Busch and his administration the authority to revise the policy as needed. Mr. Sidwell

seconded the motion. A roll call vote was taken with members voting: Ms. Stephenson, yes; Mr. Streetman, yes; Mr. Sandoval, yes; and Mr. Sidwell. The motion carried. The modified policy 18.1 Covid Vaccination - change from mandatory to strongly encouraged, and remove exemption statement, and remove the dates of vaccination requirement.

"The Board of Trustees along with the consultation of their medical provider strongly encourages, faculty, staff, and students to be vaccinated, we will continue with precautionary measures, wearing mask, distancing, washing hands, and maintaining a clean environment and the use of N95 masks as January 18, 2022."
